

COVID QUESTIONS YOU SHOULD ASK YOUR ELECTED OFFICIALS

It's not enough that a candidate or elected official says that he/she is for or against health freedom and bodily autonomy in the Covid crisis. Does that person have answers to the pressing questions about Covid?

Have you studied the U.S. constitution?

Will you act to protect my constitutional rights, regardless of situation or circumstance?

TESTING SCAMS AND INACCURATE DEATH COUNTS

Are you aware of the many reports of people making appointments to get tested for Covid who changed their minds and did not show for the appt.,

who were called and told they tested positive when they never went in for the test?

Are you aware of the many reports from doctors who, early on in the SARS-COV2 outbreak were sent health department memos telling them to list Covid-19 as the primary cause of death on death certificates, even when there was no diagnosis of Covid-19 – stating 'when in doubt, just put down Covid-19 as the cause of death.'?

And do you understand how such practices would, naturally, skew the reported death toll from Covid-19 in Ohio and other states far higher than the actual death toll?

Why haven't autopsies been done on the dead to determine whether or not the death was actually due to SARS-COV2, as is being done in other countries?

In a state of emergency that has been dragging on far longer than even a pandemic requires, this would be a means of getting accurate numbers on the actual death count. They've been wearing hazmat suits to remove the dead from hospitals so they can certainly wear the same suits to perform the autopsies.

Why are we being constantly fed disinformation on the actual impact of SAR-COV2 as a public health emergency and misinformation about number of cases and death counts that are based on computer modeling projections

MASKS IN SCHOOLS

Have you studied the evidence-based science on why masks do not prevent infection from virus such as SAR-COV2, the strain for which is a thousand times smaller than a single hair strand?

Are you aware of the OSHA and FDA guidelines on the risks and harms of wearing PPEs (including masks and cloth facial coverings) of any kind in the workplace for longer than 20-30 minutes, including carbon dioxide poisoning and hypoxia?

Have you read the statements of Anthony Fauci from late February and early March of 2020 stating that, for this virus, masks will not protect and could result in harm?

Have you seen the on-camera video demonstrations that show that masks and facial coverings do not protect from aerosolized substances of any kind, let alone a virus that is 0.125 microns in size (a thousand times smaller than a hair strand)?

MANDATORY VACCINATION

Are you aware that the CDC has published an internal document that states that the SAR-COV2 virus has never been isolated ("The analytical sensitivity of the rRT-PCR assays contained in the CDC 2019 Novel Coronavirus (2019-nCoV) Real-Time RT-PCR Diagnostic Panel were determined in Limit of Detection studies. *Since no quantified virus isolates of the 2019-nCoV are currently available...*)?

If the virus has never been isolated, how do we know that the present outbreak is even due to SARS-COV2?

If isolates of the actual virus are not available, it seems to me (and other specialists in the field of virology) that this would completely invalidate the current tests for SARS-COV2 and any vaccine now under development.

How can you have accurate tests and a vaccine that is touted as a cure to a virus that has never been properly isolated, using the bar in virology of Koch's postulate?

Are you aware that Eli Lilly, Johnson & Johnson, Moderna and Astrazeneca have all halted their Covid-19 vaccine trials due to human injury and concerns over safety of the vaccine?

Have you reviewed the peer-reviewed studies of safety concerns for these mRNA vaccines that have never been used before and never safety tested before going to human trials?

Are you aware that the standard for development of a vaccine to prevent or cure viral infection is 3-4 years that includes safety testing in animal trials first before going to human trials, with peer-reviewed oversight of development on the part of parties that have no conflict of interest connected to the vaccine development?

Have you read the National Childhood Vaccine Injury Act of 1986 in which the U.S. congress permanently indemnified all vaccine manufacturers from any liability in perpetuity for injury caused by their product – in which the Congress has declared that vaccines are '*unavoidably unsafe*'?

Have you read the Supreme Court decision in *Bruesewitz v. Wyeth Labs* that now makes it impossible to sue vaccine manufacturers for injury, however harmful, caused by their product?

So, the vaccine manufacturers have no marketing costs because government now mandates that we be injected with these vaccines – most states have removed vaccine exemptions for the CDC childhood vaccination schedule and annual flu vaccination – vaccine manufacturers have no costs for safety testing because they have no incentive to do the proper, double-blind saline placebo safety tests, because they can't be sued. They have no

development costs because my tax dollars are used to provide development grants to all of Big Pharma. Hell of a business model!! I don't know any other U.S. business afforded this kind of scam!

Understanding the above, would you take a vaccine that has not met peer-reviewed safety standards overseen by third parties with no conflict of interest?

Would you allow your children to be vaccinated under these present conditions?

Why should I or anyone else agree to take a vaccine that has not been properly safety tested, with such testing monitored by third parties with no conflicts of interest?

And why should I be punished in any situation for refusing an unsafe vaccine that has not been properly tested, and for which I cannot sue the manufacturer if I am harmed by the vaccine?

Will you go along with mandatory vaccination of the population with Covid-19 vaccines, for which it is now being stated will have to be taken 4-5 times each year under a plan that Bill Gates says will have to be implemented to vaccinate very person on the planet – when they have not been safety tested in peer-reviewed examination?

We keep hearing some government officials, including candidate Joe Biden, Governors of many states, Anthony Fauci, Dr. Redfield and the W.H.O. state that they are meeting and conferring with 'the experts,' but without listing who those experts are, along with their credentials. Do you know who these experts are?

We have the right to full and complete transparency with respect to who these people are so that we can question them on the science.

Are you aware of the studies done that have shown that unvaccinated people are, in general, healthier than those who are not? (see *Miller's Review of Critical Vaccine Studies* by Neil Zimmer).

The only way to know if a vaccine that is being safety tested on humans is actually safe is to compare the health of those who have been vaccinated with those who have not.

Will you call for, support and secure widespread, peer-reviewed studies that compare the health of the vaccinated with those who are not – studies that are conducted by those who have no conflict of interest connected to the manufacture, sales and income from the vaccines?

For every past epidemic and pandemic for which states of emergency have been declared, there has always been a posted, qualifying public statement as to how it will be determined that the outbreak is over, with an additional qualifier as to when such states of emergency will be listed (ex: when the death count has flattened to X amount per month..).

What are the qualifying criteria, based on the peer-reviewed science for which the scientists are named, that will represent the date certain for the end of the pandemic declaration and the complete lifting of the state of emergency here?
